Qualifications for III: M. Sc. (Ag.) in Agril. Statistics followed by B.Sc. (Ag.)Hons.

Qualifications for IV: H.S. (Vocational Agriculture), preference will be given to those having some survey experience in the field of Agriculture.

Qualifications for V: B.A. or B.Sc. or B. Com with at least one of the Subjects viz. Mathematics, Physics, Statistics, Economics at degree level. Preference will be given to those having at least 2 years experience in statistical work in any Govt. or non-Govt. Organization.
