Photocopy copy of the demand draft to be submitted as supporting document during submission of tender and the original copy of above mentioned demand draft to be submitted to the Principal Investigator prior to receive supply order. Document and certificate must be attached against the claim of EMD exemption, if any.

* Challan and bill should be submitted in triplicate and bank account details (Name, A/C No., IFSC & MIRC codes) of the beneficiary to be mentioned in bill.

* Bill will be processed after delivery, installation and successful demonstration.

* The vendor should have some experience for supplying of different items to any Government / Semi Government organization.
