## NOTIFICATION

In continuation of this office Notifications No.RS/D-10 dated 16.05.2021 and No. Admn/BCKV/H-2/Pt.-VI/2012/L-125 dated 01.06.2021, it is being notified for information of all concerned that the COVID-19 restrictions shall continue to remain in force up to June 30, 2021, with some modifications, as detailed below -

- (i) All establishments/sections/units of this Viswavidyalaya, including emergency services, farm and field research activities, will remain open and functional on all normal working days, as per normal working hours, with 25% of staff strength, under strict COVID-19 protocol and extant guidelines issued by the State Government.
- (ii) Accordingly, all establishments/sections/units of this Viswavidyalaya shall be manned by Faculty/ Officers/staff members by rotation basis. This rotation shall be formulated & executed the respective head of the individual section/establishment/unit through roster.
- (iii) Based on the roster prepared by the head of the individual section/establishment/unit, days on which any employee is not supposed to attend office, he/she will be required to work from home and attend to official duties from home, as and when so demanded by the concerned University authority during normal office hours. On such days they must be available on phone during normal office hours.
- (iv) Employees may also be required to attend office beyond their roster schedule, as and when so felt necessary by the concerned University authority.
- (v) In respect of operation of University farms, concerned establishment/section/unit should ensure maximum utilization of farm area by deployment of farm workers in the same pattern.
- (vi) Pre-scheduled online classes and examinations will continue as usual. However, student hostels shall continue to remain closed until further orders.
- (vii) Adequate arrangements, as per medical protocol, are to be made by the concerned University authority in respect of the foreign students staying in the hostels. No visitor shall be allowed to visit the student hostels during this period, without prior approval of the Vice-Chancellor, BCKV.

- (viii) In order to facilitate transport arrangement, during this period two University buses shall ply regularly, one originating from Buddha Park, Kalyani, and the other originating from Bagmore for to and fro journey of the employees. The bus originating from Buddha Park, Kalyani, shall be plying along bus route No. 27, via Directorate of Research, upto Barajaguli, Nadia and reach Mohanpur campus. The bus originating from Bagmore, shall reach Directorate of Research, Kalyani via Barajaguli, Gayeshpur, Kalyani Station, and ITI More. Common Service Section shall coordinate vehicular movement for Officers and other staff members.
- (ix) Physical distancing and all other COVID appropriate safety and security norms, as recommended by the State Government, should be strictly followed.

This notification is being issued in compliance with State Government Order No. 753-ISS/2M-22/2020 dated 14.06.2021, issued by the Chief Secretary, Government of West Bengal.
