Application is invited from entrepreneur/startup/businessman/individual/group for "Agribusiness incubation cum joint venture business" at Fruit Crops Breeding and Multiplication Centre (RIDF-XXIII project), Dharampur Hostel, P.O. Majhipara, P.S. Bizpur, Dist. North 24 Parganas under Bidhan Chandra Krishi Viswavidyalaya, Mohanpur, Nadia for the following areas of agribusiness as per terms and conditions (Annex-I) laid by the University. Legal agreement will be worked out between selected candidate for each of the following venture and the University.

#### Name of the ventures:

- 1. Areca leaf plate (bio-plate) making
- 2. Banana chips making
- 3. Processing of spices
- 4. Production of mushroom spawn (seed)
- 5. Macropropagation of banana
- 6. Production of vermicompost
- 7. Production of agricultural waste decomposer and biopesticide (*Trichoderma viride*, etc.)

#### Terms and conditions

- 1. Legal agreement to be worked out between selected candidate for each venture and the University.
- 2. Incubation period is 12 months (from the date of agreement) and only infrastructure facility will be provided during this period (No other support like stipend, lodging-fooding, travel allowance, etc.). By arrangement of convenient timing, same infrastructure facility shall also be available to conduct research works by the P.I.
- 3. Produce and product of different ventures during incubation period will be subject to evaluation for quality and economics and may be allowed for promotional sale. The sale proceeds, if any shall be utilized to meet part of electricity charge and raw materials.
- 4. After completion of 1 year's incubation, each venture shall come up as a joint venture business unit with sharing of net profit with RIDF-XXIII project, BCKV (Business partner 75% & RIDF-XXIII project, BCKV 25%).
- 5. For venture No.7, registration to be completed from the Directorate of Plant Protection, quarantine & Storage, Dept of Agriculture, Cooperation & Farmers Welfare, Ministry of Agriculture and Farmers Welfare, Govt of India before commercial production and marketing. Principal Investigator, RIDF-XXIII project will assist in the process of registration, if needed.
- 6. Audited statement of expenditure and net profit of each joint venture for preceding financial year shall be submitted to the Principal Investigator, RIDF-XXIII project, BCKV within April and 25% of that net profit to be deposited by May to the bank account of RIDF-XXIII project, BCKV.
- 7. Rationale of joint venture business:
  - 7.1 RIDF-XXIII project, BCKV:
  - 7.1.1 Infrastructure facility for the commercial venture, including machinery, equipment, working area, irrigation, electricity, drinking water and resting space for workers, etc.
  - 7.1.2 Technical support in production and quality maintenance
  - 7.1.3 The private partner shall deposit 25% of net profit to the bank account of RIDF-XXIII (FBMC) project within 60 days after closing previous FY along with a copy of audited document on net profit of concerned business venture.

#### 7.2 Private Partner:

- 7.2.1 Arrangement of labour and inputs for production in the commercial venture. To take of worker under accidental situation, if any.
- 7.2.2 Marketing as a product of joint venture of RIDF-XXIII (FBMC) project, BCKV (Logo and Name) and Private Partner (Name only).
- 7.2.3 The private partner will have 75% share of the profit amount of the current FY ending on 31st March, which must be presented as audited document from competent authority
- 8. Tenure of joint venture: Each joint venture business shall continue for 5 years (from the date of agreement) and agreement on renewal or fresh selection of joint venture to be done every 5 years interval with needful modification/inclusion/deletion in the agreement, if any.
- 9. Dispute adjustment through BCKV: Private partner has to first place the issue of dispute, if any to the Principal Investigator, RIDF-XXIII (FBMC) for resolving in proper channel of the University, atleast 3 months prior to seek legal assistance beyond the system of University. Withdrawal from joint venture business by either side shall follow 1 month's intimation notice and 3 months' settlement period (financial, assets, liability, etc.).
