❖ **Candidates are hereby directed to produce the following documents (SELF ATTESTED PHOTOCOPIES IN A-4 SIZE PAPER) & ORIGINAL at the time of reporting for necessary verification:**

1. Provisional admission letter.
2. H.S. Mark-sheet (both side) & Age-proof certificate (Birth Certificate/Admit Card or Certificate of Secondary Examination).
3. Certificate of the competent authority (Category – SC/ST/OBC-A/OBC-B).
4. Domicile Certificate issued by the Competent Authority (Chairman, Municipality/ Pradhan, Gram Panchayat /B.D.O./ S.D.O.). In case of residents of Municipality or Municipal Corporation where the elected board has been dissolved and there is no sitting Chairman, the certificate issued by the Executive Officer of the Municipality / Commissioner of Municipal Corporation will also be accepted..
5. AADHAAR CARD and Bank Account (if available) details must have to be submitted as per ICAR Rules for USID generation.
6. Valid Medical Certificate from proper authority for physically challenged persons.
7. Passport size Photo (4 copies).

➤ **SUBMISSION OF BLOOD ELECTROPHORESIS (THALASSAEMIA) TEST REPORT:**

The candidates are required to submit self attested copy of Blood Electrophoresis (Thalassaemia) test report to the In-Charge, Health Centre, BCKV or contact the Medical Officer, BCKV for blood test obtaining the Thalassaemia test report on the date of physical verification.

If any misrepresentation and/or suppression of facts by any candidate gets detected at any stage of physical verification, even at any time during his/ her study, his/ her admission would be cancelled.
