In continuation of earlier Notification No. A/Ph.D-12 (Part-III)/L-355 dated 17/09/2021 (Notification No. 1), it is notified to all concerned that the interested and eligible **domicile candidates of West Bengal** and who have already been listed in the provisional list for admission to Doctoral Degree Programme in the academic session 2020-21, are requested **to attend personally for Offline Counseling and Admission as per schedule (Annexure-I).**

Admission will be conducted as per Notification No.1 (one) and notification No. REG/RS-140 dt. 01/11.2021 following COVID-19 protocol. **Reservation policy for admission will be followed as per W.B. Govt. norms.**

Candidates failing to attend the counseling as per schedule (Annexure-I), will not be allowed to take admission. The decision of the Admission Committee will be final.
