The tender in sealed cover is hereby invited from bonafide parties for lease out of Mango, Jackfruit, Shimul & Bel fruits at Teaching farm, Mondouri (**Two season**). Last date of tender period **30th June, 2023**.

Teaching Farm, Mondouri

Intending parties may see the above mentioned paddy seed in the said farms on any working day within 7.00 a.m. and 12.00 noon after making prior appointment with the concerned farm Incharge.
