## CALL FOR PAPER

Abstract: Original research work not exceeding 300 words (MS Word, strictly in Times New Roman 12 point font) must reach to the Organizing Secretary by email (ipsez2021@gmail.com), not later than 20th December, 2021 along with filled up registration form and details of payment of registration fee. However for lead and invited papers, the abstract should be within 700 words.

The papers submitted for **M.J. Narasimhan Academic Merit Award – 2021** should be marked "Narashiman **Award-2021**" at right top of the text.

**Oral Presentation:** All oral presentation should be made through LCD projector and the Organizer requires a copy of presentation for making it available to the participants either through website or onsite in a CD in the Symposium.

**Poster:** The size of the poster shall be 75cm x 100cm briefly showing **Title**, **Introduction**, **Methodology**, **Significant Findings** (along with not more than threephotographs) and bulleted Summary. The poster shall be made attractive, brief, where full sentences are not mandatory. It should be composed on a single sheet with appropriate colour scheme so that the content is readable from a distance of at least one meter. The poster display requires conforming to the above standards and pasting of several small pieces of black and white A4 papers should be avoided. A two page handout may be brought to be provided to those who desire for them. A soft copy of poster is to be submitted to the organizer for making it accessible to the participants either through website or available onsite in a CD during the Symposium.

**Language:** Official language of the Symposium will be english only.

# PROF. M.J. NARASIMHAN MERIT ACADEMIC AWARD CONTEST
