## **NOTIFICATION**

In respect of students desirous of switching over from one Scholarship/Fellowship to another, this is to notify as follows –

- 1) A student (UG/PG/Ph.D.) can avail only one Scholarship / Fellowship/financial assistance from any funding agency (Government/Non-Government Organization), at any point of time.
- 2) The students (UG/PG/Ph.D.) availing any Scholarship/Fellowship/financial assistance from any funding agency at the time of applying for any new Scholarship/Fellowship/financial assistance, will be required to mention "YES" under the Column in the concerned application form in respect of "Whether received (earlier) or receiving any other fellowship / scholarship / monetary assistance from Government/Non-Government Organization for pursuing any UG/PG/PhD course", if any.
- 3) Students (UG/PG/Ph.D.) desirous of accepting any new State level or National level Scholarship / Fellowship by forgoing their existing Scholarship/Fellowship, would require to resign from the existing Scholarship / Fellowship to which they are already enrolled to and from which they are also receiving monthly benefits.
- 4) The students (UG/PG/Ph.D.) will be required to submit their resignation letter from the existing Scholarship / Fellowship, only after getting finally selected for the new Scholarship / Fellowship opted by them.
- 5) The applications for such new Scholarships and the resignation letters in respect of forgoing the existing Scholarship/Fellowship need to be forwarded through the concerned Supervisor/Guide, Department Head, and the Dean of the concerned Faculty.
- 6) Along with their resignation letter, the concerned students will also be required to give a declaration that they will be returning the Scholarship/Fellowship amounts already drawn by them for the overlapping period between the effective dates of the new and the old Scholarship/Fellowship.
- 7) The students (UG/PG/Ph.D.) will be required to refund the overdrawn Scholarship / Fellowship amounts for the overlapping periods, within one month from the date of actual disbursement of Scholarship / Fellowship under new scheme opted by them.
- 8) The refund of previous Scholarship/Fellowship amounts are to be made by the concerned students by way of Demand Draft, issued in favour of "Bidhan Chandra Krishi Viswavidyalaya", payable at SBI, Kalyani, Branch Code 1082.
