### **General Instruction:-**

- Admission will be conducted as per P.G. Notification No.1/2022-23, 2/2022-23 and as per **seat matrix (Annexure-I)**. During counseling the candidates shall have to opt the department for admission as per ranking and as per availability of seats. For all the seats reservation policy for admission will be followed as per W.B. Govt. norms.
- Hostel allotment will be done on the date of admission as per availability of seats on first come first service basis.

Candidates failing to attend the counseling as per the above mentioned schedule, will not be allowed to take admission. The decision of the Admission Committee will be final.

- **Venue: DIRECTORATE OF EXTENSION BUILDING, BCKV, Mohanpur, Nadia, West Bengal, India.**
- **Train Route Direction:** Nearest Railway Station: Kanchrapara (Eastern Railway). From station by bus (Route No. 22- Kanchrapara to Nagarukhra)/ Auto. **Stoppage-** Mohanpur, **BCKV Main Gate.**  
**OR**
- **Bus Route Direction:** National Highway 34 (Shiliguri to Kolkata / Kolkata to Shiliguri Bus route), **Stoppage - Barajaguli.** From Barajaguli by Auto/ Toto/ Rickshaw van /Bus to Mohanpur, BCKV Main Gate (Approx 5 minutes)
- **Candidates are hereby directed to produce the following documents (SELF ATTESTED PHOTOCOPIES IN A-4 SIZE PAPER) & ORIGINAL at the time of counselling and admission for necessary verification:**

- (i) Download online application form
- (ii) Mark-sheets/Grade cards of Examination: H.S. Examination (10+2 Standard), Bachelor Degree (4-Years Degree Course) [Both Side separately]
- (iii) Age-proof certificate [Birth Certificate/ Admit Card or Certificate of Secondary Examination (10<sup>th</sup> Standard)].
- (iv) SC/ST/PwD/OBC-A/OBC-B certificates from the competent authority (for reserved seat).
- (v) Domicile certificate issued by the competent authority (Chairman or Executive Officer of Municipality/ Commissioner or Administrator of Municipal Corporation /Pradhan, Gram Panchayat /B.D.O./ S.D.O.).
- (vi) AADHAAR card of the candidate.
- (vii) Two (2) copies of recent colour passport size photograph.
- (viii) Self-attested copy of valid medical certificate from appropriate authority (Sub-Divisional Medical Officer, Superintendent of State Hospital or above category) for person with disability (PwD) candidates.

#### ➤ **Accreditation Certificate:**

**For M.Sc. (Agriculture/Horticulture):** Applicants having bachelor degree from other University or college will have to produce a certificate from appropriate authority mentioning that his/her Faculty/College is either ICAR-accredited or is aided by State Government before taking admission/ reporting, failing which his/her candidature is liable to be cancelled.

**For M.Tech. Agril. Engineering:** Applicants having Bachelor Degree from other University or college will have to produce a certificate from appropriate authority mentioning that his/her Faculty/ college/ Programme is either AICTE approved or is aided by State Government, before taking admission/ reporting failing which his/her candidature is liable to be cancelled.

➤ **SUBMISSION OF BLOOD ELECTROPHORESIS (THALASSAEMIA) TEST REPORT:**

The candidates are required to submit self attested copy of Blood Electrophoresis (Thalassaemia) test report to the In-Charge, Health Centre, BCKV.
