**Notice Inviting Quotation**

The Officer-in - Charge, AICRP on Cashew, BCKV Jhargram –721507, West Bengal is inviting sealed quotation from competent and bonafide vendors /parties/ distributors/dealers/agents/manufacturers having registration of GST for submission of bids within **10 days from the date of publication of quotation notice** as per specifications appended against the following item for **AICRP on Cashew, RRS, BCKV Jhargram –721507**.

**Terms & Conditions:**

**I. Submission of quotation:** the quotation shall reach office of the **AICRP on Cashew, RRS, BCKV Jhargram –721507 online within 10 days from the date of publication of quotation notice**.

**II. Technical bids** will be evaluated first by the Indenter and the financial bids will be opened of those bidders who qualified in technical bids.

**III. Price:** The price of item should be quoted in INR & net per unit (including taxes and duties, etc). However, University will provide valid DSIR and authorization certificate to the clearing agent, if required. Quotation must include all essential accessories (as mentioned for the item) from reputed company. Without essential accessories tender will be considered as incomplete. Quoted rates must be FOR DESTINATION (including packing, insurance and delivery charges up to the office of the **AICRP on Cashew, RRS, BCKV Jhargram –721507**) including installation. Payment will be processed for online payment only on receipt of bills, chalan and other required documents after satisfactory installation and demonstration of the system. The bidders must stipulate the delivery period of the same.

**IV. Payment** will be made after satisfactorily performance of the items.

**V. The vendor** should have experience for supplying of different items to any Government / Semi Government organization.

**VI. Important safety standards**

The machinery must confirm to International EMC and Safety standards.

**VII. Warranty**

Warranty period minimum 1 Year or more from the date of supply. Manufacturer must have their own dedicated Service Centre available in India and details of Service Centre must be provided while uploading their Quotations.

**I X. Supporting documents**

Quotation papers should accompany authorization certificate from original manufacturer, trade license, GST registration, proprietary certificate (if any) etc. Photocopy (self attested) of the original supporting documents in favour of the specification –claim for each item must have to be uploaded separately, if available. User list



along with certificate from reputed users also need to be uploaded. Scan copy of supporting document of assured after sales services in Eastern India and availability of spare parts need to be uploaded.

**X. The Viswavidyalaya reserves the right to accept or reject any tender without showing reason.**

**XI. EMD:** Vendors are requested to pay the requisite amount (in INR) as EMD Rs. 1000/- in draft. Scan copy of the requisite draft must be included with the supporting document during submission of sealed quotation. Without EMD quotations will not be considered for technical or financial comparison. Draft must be in favour of 'Bidhan Chandra Krishi Viswavidyalaya' payable at Kalyani (IFSC: SBIN0001082). However, bidders are requested not to send the original draft during tendering process. EMD exemption, however, will be applicable as per Govt. norms.
