**Sub: E-tender Notice regarding lease out for collection of Mango fruits from the Mango Orchards of AICRP on Agroforestry Project (Experimental Plot) under RRS, Jhargram farm, Bidhan Chandra Krishi Viswavidyalaya for the coming 02 (two) fruiting seasons in the year 2023 and 2024 (Last date of tender period 31<sup>st</sup> July,2024).**

1. The applicant has to apply online in **<wbtenders.gov.in>** portal.
2. At the time of applying online in **<wbtenders.gov.in>** portal, the applicant has to download the specified Application format and after filling up the format completely, the same has to be scanned and scanned copy should be uploaded in the "**Application folder**" (in **.pdf** format).
3. The Applicant has to upload scanned copy of self attested photocopy of his/her Aadhaar Card in the "**Aadhaar Card**" folder while applying online in ( in **.pdf** format).
4. The Applicant has to upload scanned copy of self attested photocopy of his/her PAN Card in the "**PAN Card**" folder while applying online ( in **.pdf** format).
5. The applicant must upload duly filled in specified Application format, Aadhaar Card and PAN Card in the above stated manner, otherwise his/her offer will be rejected straightway and his/her EMD will be forfeited without any further reference to his/her The applicants must retain hard copies of the uploaded documents because those may be required to be submitted in later stage.
6. The applicant **has to bid above the minimum price fixed for this purpose which is Rs. 2,50,000/- (Rupees two lakh fifty thousand only)**. Any bid below the minimum price will not be considered and in that case, the EMD will be forfeited and/or the Authority can take appropriate action.
7. An amount of **Rs. 6,250/- (Rupees six thousand two hundred fifty only)** should be deposited as EMD at the time of applying online.

The selected bidder has to deposit **Rs. 25,000/- (Rupees twenty five thousand only) as Refundable Security Deposit**. The EMD amount **Rs. 6,250/- (Rupees six thousand two hundred fifty only)** will be converted as part of Refundable Security Deposit. Balance amount of Refundable security deposit i.e. (Rs. 25,000/- - Rs. 6,250/-) **Rs. 18,750/- (eighteen thousand seven hundred fifty only)** has to be deposited by the selected bidder in the form of A/C Payee Demand Draft drawn on any Nationalized Bank in favour of "**Bidhan Chandra Krishi Viswavidyalaya**" payable at SBI, Kalyani Branch ( IFSC-SBIN0001082) or at PNB, BCKVV Branch (IFSC- PUNB0075920).

The above said two Demand Drafts (one for balance security deposit and another for his/her bidded amount) have to be deposited **simultaneously** within the time period which will be intimated to his/her through formal communication. Failure to do so, will lead to cancellation of the offer and forfeiture of EMD without any further reference to his/her.

10. Immediately after completion of harvest of Mango fruits in the fruiting season of the year 2024, the selected bidder has to hand over the mango orchards to the authority, otherwise his/her refundable security deposit will be forfeited and/or authority can take appropriate action.
11. After handing over mango orchards to the Authority, Refundable Security Deposit will be released on the basis of satisfactory performance certificate from the Farm In-Charge, RRS, Jhargram Farm, B.C.K.V. in favour of the selected bidder. For this purpose the selected bidder has to make an application enclosing photocopy of the first page of his/her own Bank Passbook and photocopy of his/her Aadhaar card. No interest will be payable at the time of releasing Refundable security Deposit.
12. The Authority does not give any kind of guarantee whatsoever regarding the production of fruits in the orchards.
13. The authority shall not be held responsible for any kind of damage/ pilferage/ theft of fruits/trees. With the permission of the Authority, the selected bidder may make necessary arrangement for protection of fruits /trees at his/her own risk and responsibility. The authority shall not be held responsible for any kind of damage to the trees, due to physical condition of the trees and/or natural calamities, if any.
14. Before spraying any kind of Agricultural Chemicals in the trees, the selected bidder has to take advice from the In-Charge, AICRP on Agroforestry project and Farm In-Charge, RRS, BCKV, Jhargram as per his/her advice, the selected bidder may start spraying in the trees. The selected bidder has to remain cautious so that there is no damage to the trees/orchards due to non-compliance of such advice and/or terms and conditions of this notice. If there is any damage to the trees/orchards except due to physical condition of the trees and/or natural calamities, the Authority can forfeit refundable security deposit and/or can realize compensation and/or cancel the permission for Collection of fruits, as stated above and/or take an appropriate action.



25. At the time of harvesting of fruits, absolute care should be taken by the selected bidder so that there is no damage to the branches of the trees/properties of the farm.
26. The selected bidder or his/her nominated/ authorized persons shall not indulge in any activity which is detrimental to the interests of the research experiment and /or Farm in general, otherwise the entire responsibility shall lie on the selected bidder and in that case authority can take appropriate action which may lead to forfeiture of Refundable security deposit and/or cancellation of the permission for collection of fruits, as stated above and/or appropriate legal action and/or any other action which the authority may deem fit.
