At the time of applying online in wbtenders.gov.in portal, the applicant has to download the specified Application format and after filling up the format completely, the same has to be scanned and scanned copy should be uploaded in the "Application folder" (in .pdf format).

No interest will be payable at the time of releasing Refundable security Deposit.

- 13. The authority shall not be held responsible for any kind of damage/ pilferage/ theft of fish in ponds. With the permission of the Authority, the selected bidder may make necessary arrangement for protection of ponds at his/her own risk and responsibility. The authority shall not be held responsible for any kind of circumstances of ponds, due to physical condition of the ponds or natural calamities, if any.
 - 14. Before using any kind of Agricultural medicine/fertilizer in the ponds, the selected bidder has to take advice from the In-Charge, C.R. Farm as per his/her advice. The selected bidder has to remain cautious so that there is no damage to the trees/orchards around the ponds area due to non-compliance of such advice and/or terms and conditions of this notice. If there is any damage to the ponds and trees/orchards around the ponds area except due to physical condition and/or natural calamities, the Authority can forfeit refundable security deposit and/or can realize compensation and/or cancel the permission for Cultivation of fish, as stated above and/or take an appropriate action.
 - 15. The selected bidder has to keep the ponds clean all the time. After cultivation of fish in the year 2024, the ponds should be cleaned properly before handing over to the Authority.
