NOTIFICATION

With the commencement of academic session around the corner, the University is resolute to put to force the anti-ragging guidelines in all the campuses of BCKV. This in the wake of unfortunate life loss at the nationally high rank University/ Institute in this State, to prevent recurrence of any such incidents.

The university has been sharing all information with the students of University and those related anti-ragging efforts and laid down principles, during recent past, for students and staff members of the Viswavidyalaya. As per instruction of the BCKV administration, the Deans led by DSW, the administrative controlling officer Registrar, the students have been formally informed about national guidelines regarding "Do's" and "Don't" with the students of all faculties.

In abiding to the principles of anti-ragging stern action will be taken against the offenders.

Since the national directives from Supreme Court, UGC, State and Central Education Ministries to all Universities remaining mandatory for all students pursuing higher studies, the administration will be left with no other alternative but to take all such steps as laid down in the National directives and to immediately inform all such Civil Authorities of the District and the Department of Education and Home immediately.

It is a general reminder to all students of the University and all other concerned sections of the University.

However, the University is mandated to arrange for allotment of residential arrangement and study in isolation, as far as affordable, will be taken up. Accordingly re-allotment of existing boarders for specific batches have become a compulsion to the administration of the university.

The university solicits cooperation from all sections of the university and from civil administration in its efforts to enforce anti-ragging guidelines within its premises.
