Before spraying any kind of Agricultural Chemicals in the trees, the selected bidder has to take advice from The Farm In-Charge, RRS, Jhargram Farm, B.C.K.V. and In-Charge, AICRP on Agroforestry, RRS, Jhargram, BCKV as per his/her advice, the selected bidder may start spraying in the trees. The selected bidder has to remain cautious so that there is no damage to the trees/orchards due to non-compliance of such advice and/or terms and conditions of this notice.
