- 1. The applicant has to apply online in <wbtenders.gov.in> portal.
- 2. At the time of applying online in <wbtenders.gov.in> portal, the applicant has to download the specified Application format and after filling up the format completely, the same has to be scanned and scanned copy should be uploaded in the "Application folder" (in .pdf format).
- 3. The Applicant has to upload scanned copy of self attested photocopy of his/her Aadhaar Card in the "Aadhaar Card" folder while applying online in (in .pdf format).

- 14. Before spraying any kind of Agricultural Chemicals in the trees, the selected bidder has to take advice from The Farm In-Charge, C.R. Farm, Gayeshpur, B.C.K.V. as per his/her advice, the selected bidder may start spraying in the trees. The selected bidder has to remain cautious so that there is no damage to the trees/orchards due to non-compliance of such advice and/or terms and conditions of this notice.
