- 3. The rate below the base price mentioned in the notice will not be considered.
- 4. The selected bidder/ bidders have to deposit the entire quoted amount at a time to the account of Nadia KVK, Gayeshpur, Nadia within seven (7) days of acceptance of the tender.

- 7. Maintenance and cleaning of above mentioned trees and fields will be done by the party. Only irrigation water will be provided as and when required during leased out period. Otherwise your tender is cancelled.
- 8. Pruning and damaging of branches/trees of the experimental plants would not be done during harvesting.
