## P.G. Notification No. 1/2025-26

### Sub: Admission to Master's Degree Programme for the session 2025-26

Applications are invited from Indian citizens only for admission to Master's Degree 2 Year (4 Semester) Programme of Bidhan Chandra Krishi Viswavidyalaya (BCKV) at Mohanpur Campus for the academic session 2025-26. Interested candidates may apply for admission to the Master's Degree Programme through our **Online Admission Portal** ([www.bckvadmission.in](http://www.bckvadmission.in)) and for other information visit our university website ([www.bckv.edu.in](http://www.bckv.edu.in)).

#### 1. ALLOTMENT OF SEATS: As per Annexure-I and II

#### 2. Procedure of filling up of PG seats :

Out of total seats (Programme-wise):

- 70% seats will be reserved as University seats.
- 30% seats will be reserved as ICAR quota. ICAR's nominees will be considered as per prevailing rules.

#### All Master's Degree seats, excepting ICAR seats, will be filled up in the following manner:

- 2.1. **Out of the 70% University seats:** 80% seats will be filled from domicile of West Bengal and remaining 20% will be filled up from open category (domicile and non-domicile). **During admission 80% domicile category seats will be filled first and then remaining 20% open category seats will be filled.**
- 2.2. Eighty percent (80%) of the seats in each department rounded off to nearer absolute number will be filled up category-wise (UR/SC/ST/OBC-A/OBC-B/PwD/EWS) as per reservation policy of the Government of West Bengal on the basis of merit list.
- 2.3. Reservation policy of Government of West Bengal will also be followed in respect of filling the remaining 20% open category seats.
- 2.4. **No benefit of reservation will be extended to the non-domicile candidates.**
- 2.5. In case any seat falls vacant due to non-availability of domicile candidates, it will be filled up by non-domicile candidates on the basis of merit list.
- 2.6. **The ICAR left over seats, if any, will be filled up by the students of BCKV only.**
- 2.7. **Only one time up-gradation will be allowed module-wise.**
- 2.8. Admission test (to be conducted by BCKV) and also academic record will be considered for preparation of merit list.

#### 3. GUIDELINES FOR ENTRANCE EXAMINATION OF MASTER'S DEGREE PROGRAMME :

- 3.1. Admission test will be conducted by BCKV.
- 3.2. Under three Faculties (Agriculture, Horticulture & Agricultural Engineering) there will be **total nine (9) Modules** to choose from **Annexure-III**.
- 3.3. The nine modules are categorised under three Groups- A, B & C (**Annexure-III**).
- 3.4. **Admission test will be held Module-wise.**
- 3.5. Admission test for all the modules will be held on the same day in three separate time slots, specified for the three Groups (A/B/C) [**Annexure-III**].
- 3.6. Candidates with Agriculture and Horticulture background can opt for **any two modules** under **any two Groups** (any one module under each Group).

- 3.7. **Module 9 – Agricultural Engineering will be available to Agricultural Engineering graduates only.**
- 3.8. Agriculture graduates will have **eight (8) modules** (Module 1 to 8) to choose from and Horticulture graduates will have only **seven (7) modules (Modules 1 to 8, except Module 5)** to choose from **[B.Sc. (Hort.) graduates will not be eligible to apply for Agronomy Module (Module 5) [Annexure-III].**
- 3.9. At the time of counselling, as per merit list, the candidates shall get the opportunity of choosing a programme of study under the particular Module for which they may get selected (details of courses is provided in **Annexure-III**).
- 3.10. **Candidates desiring to apply under two modules, will be required to fill only one Application Form, and will not be required to pay any extra application fee.**
- 3.11. Admission test will be of 60 (sixty) marks. The question paper will comprise of 60 MCQs of 1(one) marks each and with 4 (four) unambiguous alternatives.
- 3.12. The duration of the admission test will be of 1 (one) hour.
- 3.13. **There will be negative marking of 0.25 for each wrong answer.**

**4. Merit list will be prepared according to the following weightage:**

**Note:** In respect of candidates who earlier got **admitted in B.Tech. (Agril. Engg.) Programme through Lateral Entry Scheme**, in their case marks obtained by them in Diploma course's score will be considered in place of H.S. score.

**5.1. Faculty of Agriculture:**

(1) Biochemistry (2) Molecular Biology and Biotechnology (3) Plant Physiology (4) Genetics and Plant Breeding (5) Plant Pathology (6) Seed Science and Technology (7) Agricultural Meteorology (8) Soil Science (9) Agricultural Chemicals (10) Soil and Water Conservation (11) Entomology (12) Agronomy (13) Agricultural Economics (14) Agricultural Extension Education (15) Agricultural Statistics.

**5.2. Faculty of Horticulture:**

(1) Vegetable Science (2) Fruit Science (3) Post Harvest Management (4) Floriculture and Landscaping (5) Plantation, Spices, Medicinal and Aromatic Crops.

**5.3. Faculty of Agricultural Engineering:**

(1) Farm Machinery and Power Engineering (2) Processing and Food Engineering.

## 6. ELIGIBILITY FOR ADMISSION :

### 6.1. Agriculture and Horticulture (M.Sc.):

- a) Candidates must have passed 4-year Bachelor Degree Examination in Agriculture/ Horticulture. General, OBC and EWS candidates must secure Overall Grade Point Average (OGPA) of at least 6.50 in 10.00 scale whereas for SC/ST/PwD candidates, the said requirement is at least 5.50 in 10.00 scale. In traditional system where grade-points are not awarded, the General and OBC category candidates must have secured at least 60% marks, whereas for SC/ST/PwD categories, the requirement is at least 50% marks.
- b) Candidates must have passed Higher Secondary or equivalent examination (10+2) in General stream or Vocational stream securing at least 50% marks in aggregate for General, OBC and EWS categories, whereas for candidates under SC/ST/PwD categories the said requirement is at least 40% marks.
- c) **The qualifying marks of the entrance examination for all categories will be notified later on.**
- d) All the candidates are required to submit self attested photocopy of all transcripts at the time of Counseling/ admission.

### 6.2. Agricultural Engineering (M.Tech.):

- a) Candidates must have passed 4-year Bachelor Degree Examination in Agricultural Engineering. General, OBC and EWS candidates must secure Overall Grade Point Average (OGPA) of at least 6.50 in 10.00 scale, whereas for SC/ST/PwD candidates, said requirement is at least 5.50 in 10.00 scale. In traditional system where grade points are not awarded, the General, OBC and EWS category candidates must have secured at least 60% marks, whereas for SC/ST/PwD categories the requirement is at least 50% marks.
- b) Candidates must have passed Higher Secondary or equivalent examination (10+2) and securing at least 50% in aggregate for General, OBC and EWS candidates and 40% for SC/ST/PwD candidates.
- c) In respect of candidates who earlier got admitted in B.Tech. (Agril. Engg.) programme through Lateral Entry Scheme, marks obtained by them in Diploma course's score will be considered in place of H.S. score. In this case, student under Lateral Entry Scheme, candidate must have passed with 60% marks under General, OBC and EWS category and 55% marks for SC/ST/PwD category.
- d) **The qualifying marks of the entrance examination for all categories will be notified later on.**
- e) All the candidates are required to submit photocopy of all the transcripts at the time of Counseling/reporting for admission.

## 7. MODE OF APPLICATION (ONLINE) AND PAYMENT OF FEES (ONLINE) :

Candidates have to apply online through the BCKV admission portal ([www.bckvadmission.in](http://www.bckvadmission.in)) and application fee is to be paid as per the following rates.

**Application fees once paid will not be refunded.**

General/OBC/EWS category	Rs. 1,800/-

**Note :** Candidates desiring to apply under two modules, will be required to fill only one Application Form and will not be required to pay any extra application fee.

## 8. CANCELLATION OF ADMISSION :

If it is found at any stage that a candidate has obtained admission by misrepresentation and/or suppression of facts, his/her admission shall be liable to be cancelled, without assigning any reason.

- AAPAR ID (formerly Academic Bank of Credits) is mandatorily required at the time of online application form.
- Personal Information Details of the Candidate:- Candidate's full name, father's name, mother's name, candidate's mobile number, own e-mail ID, guardian's name, guardian's mobile number, relationship with guardian, date of birth, category (General/SC/ST/OBC-A/OBC-B/PwD/EWS), In-service (yes/no), cast certificate number (if any), gender (male/female/others), domicile (West Bengal), nationality (Indian), religion, student's AADHAAR number.
- Address: Permanent address and correspondence address.

## 11. DOCUMENTS REQUIRED FOR UPLOADING AT THE TIME OF FILLING UP ONLINE:

### 11.1. APPLICATION FORM (Scan copy of original document):

- Colour Photograph, Signature, Birth Certificate/Certificate of Secondary Examination, Mark Sheet of Higher Secondary Examination (10<sup>th</sup> +2 standard)/H.S. (Vocational Examination) [Both Side], Caste Certificate (if any), PwD Certificate (only for PwD candidates), EWS Certificate (if any), Student's Aadhaar Card, Parents Aadhaar Card.
- Incomplete application forms will be liable for cancellation.

### 11.2. GUIDELINES FOR SUBMISSION OF ON-LINE APPLICATION FORM:

- Open BCKV website at [www.bckvadmission.in](http://www.bckvadmission.in) and click on "Admission".
- Then click on Click Here "PG Admission 2025-2026" and then "Sign up" for new application.
- After creating a new account, if you are not able to continue the online application procedure, you can always login into the system using User Name and Password provided by the candidate at time of creation of his/her account to continue the online application procedure.
- Fill in the online application form carefully with all details.

e) **Photo and signature specifications:**

- i. The recent photograph should be in colour with 80% face (without mask) visible including ears against a **white background**.
- ii. The scanned photograph and signature should be in JPG/JPEG/PNG format (clearly legible).
- iii. Scanned Photo with dimension 35mm x 45mm or 320 x 240 pixel (size should be between 10-100 kb)
- iv. Scanned signature with dimension 50mm x 20mm or 140 x 60 pixel (size should be between 30-50 kb)

11.3. **The following documents should be uploaded in PDF format & Size (40 KB and 1024 KB):**

- a) Birth Certificate/Certificate of Secondary Examination (10<sup>th</sup> Standard) for age proof.
- b) Mark Sheet of Higher Secondary Examination / H.S (Vocational) Examination (Both side separately) [10+2 standard].
- c) Certificate (SC/ST/OBC/PwD/EWS) category.
- d) Student's Aadhaar Card.
- e) Parents' Aadhaar Card .
- f) Application process is completed after successful filling up the relevant data and uploading of required documents.
- g) Students have to bring 2 (two) copies print application form (A4 size) at the time of counselling and admission.
- h) Candidates will be able to download his/her admit card using User ID and Password
- i) Correction/Modification of application form, if required (The candidate may correct his/her application using User ID and Password).

12. **SUBMISSION OF FOLLOWING DOCUMENTS BY THE CANDIDATE AT THE TIME OF REPORTING (AS UPLOADED AT THE TIME OF ONLINE APPLICATION):**

- b) Valid EWS certificate should be submit on the day of physical verification of certificates and admission for EWS category. Failing to submit desired certificate on that date shall lead to cancellation of the candidature who had applied under EWS category.

**12.5. OBC:**

- a) OBC-A and OBC-B reservation policy will be followed according to notification No. 1056-BCW/MR-33/2025(Pt.1) dated the 27th May, 2025 & No.1057-BCW/MR38/2025 Dated the 27th May, 2025 & No.1107-BCW/MR-38/2025 dated the 3rd June, 2025, No. 917-BCW/MR-33/2025 Dated the 8th May, 2025 and No.1106-BCW/MR-33/2025 Dated the 3rd June, 2025.
- b) **Revalidated OBC certificate of the competent authority as per recent guidelines of Govt. of W.B.**

12.6. Domicile certificate issued by the competent authority (S.D.O./D.M.).

12.7. AADHAAR Card of the candidate.

12.9. Self-attested copy of valid medical certificate from appropriate authority (Sub-Divisional Medical Officer, Superintendent of State Hospital or above category) for persons with disability (PwD candidates).

**12.10. BLOOD ELECTROPHORESIS (THALASSAEMIA) TEST REPORT:**

Candidates who will be admitted in this University are required to submit self-attested copy of Blood Electrophoresis (Thalassaemia) test report to the Registrar's Department (Admission & Scholarship Section) within 1 (one) month from the date of admission.

**13. ADMIT CARD For Entrance Examination:**

Candidates eligible to appear in the Entrance Examination of M.Sc./ M.Tech. programme are required to bring the computer generated Admit Card along with two copies of duly self attested passport size photograph on the day of the entrance examination.

**14. SCHEDULE FOR ENTRANCE EXAMINATION:**

- a) **Entrance test will be held Module-wise;**
- b) Entrance test for all the modules will be held on the same day in three separate time slots, specified for the three Groups (A/B/C) [as per Annexure-III]

**15. Anti-Ragging Regulation (as per UGC Regulation) & BCKV Undertaking :**

- b) On the day of reporting, candidates who will be found eligible after verification of documents with the data provided in the application form will only be allowed to take final admission.
