The price of item should be quoted in INR per unit inclusive of all Taxes, if any, transport charges, serving and cleaning, etc. Quotation must include all essential accessories (as mentioned for the item) from reputed company. Without essential accessories tender will be considered as incomplete.

4. Payment will be processed for online payment only on receipt of bills, challan and other required documents after satisfactory installation and demonstration of the system. The bidders must stipulate the delivery period of the same.
5. Quotationers should have valid PAN Card, Current Trade License, GST Certificate, and all necessary documents and experiences related to this work, all documents to be submitted with the quotations.
