Sub: E-tender Notice regarding lease out for collection of Mosambi fruits from the Mosambi Orchards in RRS, Jhargram Farm, Bidhan Chandra Krishi Viswavidyalaya upto 31st October, 2026.

A. Under RRS, Jhargram Farm, B.C.K.V (General Plot).

1. The applicant has to apply online in wbenders.gov.in portal.
2. At the time of applying online in wbenders.gov.in portal, the applicant has to download the specified Application format and after filling up the format completely, the same has to be scanned and scanned copy should be uploaded in the "Application folder" (in .pdf format).
3. The Applicant has to upload scanned copy of self attested photocopy of his/her Aadhaar Card in the "Aadhaar Card" folder while applying online in (in .pdf format).
4. The Applicant has to upload scanned copy of self attested photocopy of his/her PAN Card in the "PAN Card" folder while applying online (in .pdf format).
5. The applicant must upload duly filled in specified Application format, Aadhaar* Card and PAN Card in the above stated manner, otherwise his/her offer will be rejected straightway and his/her EMD will be forfeited without any further reference to his/her The applicants must retain hard copies of the uploaded documents because those may be required to be submitted in later stage.
6. The applicant **has to bid above the minimum price fixed for this purpose which is Rs. 7,00,000/- (Rupees Seven lakh only)**. Any bid below the minimum price will not be considered and in that case, the EMD will be forfeited and/or the Authority can take appropriate action.
7. An amount of Rs. 17,500/- (Rupees Twelve Seventeen thousand five hundred only) has to be deposited by the bidder in the form of A C Payee Demand Draft drawn on any Nationalized Bank in favour of "Bidhan Chandra Krishi Viswavidyalaya" payable at SBI, Kalyani Branch (IFSC-SBIN0001082) or at PNB, BCKVV Branch (IFSC- PUNB0075920) through wbenders.gov.in at the time of applying online (upload a photocopy of Demand Darft) and the Original draft should be deposited / reached to The Director of Farm office / Farm In-Charge within mentioned stipulated time or Valid/ Current MSME.
8. EMD should be deposited through wbenders.gov.in.
9. The selected bidder has to deposit Rs. 70,000/- (Rupees Seventy thousand only) as **Refundable Security Deposit**. The EMD amount of Rs. 17,500/- (Rupees Twelve Seventeen thousand five hundred only) will be converted as part of Refundable Security deposit. Balance



amount of Refundable security deposit i.e. (Rs. 70,000/- - 17,500/-) = **Rs. 52,500/- (Rupees Fifty two thousand five hundred only)** has to be deposited by the selected bidder in the form of A/C Payee **Demand Draft** drawn on any Nationalized Bank in favour of "**Bidhan Chandra Krishi Viswavidyalaya**" payable at SBI, Kalyani Branch (IFSC-SBIN0001082) or at PNB, BCKVV Branch (IFSC- PUNB0075920) or to the **Comptroller's Department, Cash Section having approval from Director of Farms, BCKV. After depositing the requisite SD amount to Comptroller's Department, a receipt has to submitted to the Directorate for further process.**

The above said 02 (two) **Demand Drafts** (one for balance security deposit and another Demand Draft for at the time of applying online) with entire bid amount have to be deposited **simultaneously** within the time period which will be intimated to his/her through formal communication to the Farm In-Charge. Failure to do so, will lead to cancellation of the offer and forfeiture of EMD without any further reference to his/her.

10. Immediately after completion of harvest of Mosambi fruits in the fruiting season of tender period, the selected bidder has to hand over the Mosambi orchards to the authority, otherwise his/her refundable security deposit will be forfeited and/or authority can take appropriate action.
11. After handing over Mosambi orchards to the Authority, Refundable Security Deposit will be released on the basis of satisfactory performance certificate from the Farm In-Charge, RRS, Jhargram Farm B.C.K.V. in favour of the selected bidder. For this purpose the selected bidder has to make an application enclosing photocopy of the first page of his/her own **Bank Passbook** and photocopy of his/her **Aadhaar card**. No interest will be payable at the time of releasing Refundable security Deposit.
12. The Authority does not give any kind of guarantee whatsoever regarding the production of fruits in the orchards.
13. The authority shall not be held responsible for any kind of damage/ pilferage/ theft of fruits/trees. With the permission of the Authority, the selected bidder may make necessary arrangement for protection of fruits /trees at his/her own risk and responsibility. The authority shall not be held responsible for any kind of damage to the trees, due to physical condition of the trees and/or natural calamities, if any.
14. Before spraying any kind of Agricultural Chemicals in the trees, the selected bidder has to take advice from The Farm In-Charge, RRS, Jhargram Farm B.C.K.V. as per his/her advice, the selected bidder may start spraying in the trees. The selected bidder has to remain cautious so that there is no damage to the trees/orchards due to non-compliance of such advice and/or terms and conditions of this notice. If there is any damage to the trees/orchards except due to physical condition of the trees and/or natural calamities, the Authority can forfeit refundable security deposit and/or can realize compensation and/or cancel the permission for Collection of fruits, as stated above and/or take an appropriate action.
15. The selected bidder has to keep the orchards clean all the time. After collection of fruits in the fruiting season of tender period, the orchards should be cleaned properly before handing over the orchards to the Authority.
16. Authority reserves the right to add/delete/change/alter/modify terms and conditions of this tender notice at any time without assigning any reason whatsoever.
17. Authority reserves the right to cancel any part or whole of this tender without assigning any reason thereof.
18. Bidding the highest rate does not automatically entitle an applicant to get the permission for collection of fruits, as stated above.

20. If any dispute arises, decision of the Authority will be final and binding upon all concerned.
21. The Authority is not liable to accept the highest bid and reserves the right to reject any offer/ all offers without assigning any reason whatsoever.

Interested persons can inspect the Mosambi orchards in RRS, Jhargram Farm B.C.K.V. on any working day of the Viswavidyalaya between 7:30 a.m. to 12:00 noon with the prior permission of the Farm In-Charge, RRS, Jhargram Farm B.C.K.V. No farm equipments / implements will be provided to the selected bidder.
23. The selected bidder has to maintain close contact with the Farm In-Charge, RRS, Jhargram Farm B.C.K.V. during the entire period.
24. At the time of harvesting of fruits, absolute care should be taken by the selected bidder so that there is no damage to the branches of the trees/properties of the farm.
25. The selected bidder or his/her nominated/ authorized persons shall not indulge in any activity which is detrimental to the interests of the research experiment and /or Farm in general, otherwise the entire responsibility shall lie on the selected bidder and in that case authority can take appropriate action which may lead to forfeiture of Refundable security deposit and/or cancellation of the permission for collection of fruits, as stated above and/or appropriate legal action and/or any other action which the authority may deem fit.
26. The decision of the authority in any case is final.


