The tender in sealed cover is hereby invited from bonafide parties for disposal of Cashew nut, Sarbati lemon, Orange and Rough lemon at Teaching farm, Mondouri (in the ensuing season i.e. 2019 to 2021 upto 31<sup>st</sup> September 2021).

#### Teaching Farm, Mondouri.

- a) Cashew nut trees - 200 Nos. (only for fruits)
- b) Sarbati lemon trees - 80 Nos ( Only for fruits)
- c) Orange trees - 25 Nos. ( Only for fruits)
- d) Rough lemon - 20 Nos. ( Only for fruits)

Intending parties may see the above mentioned fruits at Teaching Farm on any working day within 7.00 a.m. and 01.00 P.m after making prior appointment with the Incharge, above Farms.

4. No liabilities of any theft of fruits or damage of fruits would be borne by the University after the acceptance of tender.
5. Prunning and damage of branches of the experimental plants would not be allowed during intercultural operataion & hervesting.
