The tender is hereby invited from bonafide parties for disposal of following non seed paddy at DSF "C" Unit, Kalyani as stated below.

a) Paddy (IET-4786) - 04 M. Ton. (approx)

Intending parties may see the above mentioned non seed paddy in the said farms on any working day within 7.00 a.m. and 12.00 noon after making prior appointment with the concerned farm Incharge.
