TENDER NOTICE

Tender is hereby invited from bonafide parties for lease out of the ponds at Mohanpur Campus in BCKV, Mohanpur, under the terms and conditions failing which the tender will be deemed as cancelled and the "Earnest Money/ Security Deposit" will be forfeited.

Main Campus – 04 Nos ponds (Area approx - 7.5 Bigha)
1. Infront of Lady's Hostel – one no. , 2. Behind of Lady's Hostel - one no. 3. Backside of Central Library- one no. 4. Infront of Ph. D Hostel – one no. (Total 4 Nos. ponds)

The " Security Deposit/ Earnest Money" for the pond is Rs. 80,000/- (Eighty thousand) only.
The last date lease out period of pond to 31st March 2022.

Intending parties may see the above mentioned ponds in the main campus on any working day within 10.00 a.m. to 04.00 P.M. after making prior appointment with the Director of Farms, BCKV, Mohanpur, Nadia.

Each party has to abide by the terms and conditions mentioned hereunder and any breach, abrogation of the same will automatically lead to cancellation of tender and forfeiture of "Earnest Money / Security Deposit".

1. The rate to be submitted by the party must be written legibly both in figure and in words on a plain sheet duly signed along with detailed mailing address & mobile No.
2. The entire cost of the above ponds as would be offered by the party and duly accepted by the authority will have to be paid to the Incharge Teaching Farm, Mondouri, against demand draft, within 7 days from the date of acceptance of the tender.
3. The tender along with requisite " Earnest Money "as specified below must be submitted for the above mentioned pond within the last date given bellow.
4. A photocopy of Identity card with photograph, such as EPIC, Driver license, passport, Adhar Card etc must be enclosed with tender.
5. The authority may take water from the said pond or may use the water of pond at any time, if need be.
6. Erection of hut and cultivation of vegetable at the embankment of the said water bodies is strict prohibited.
7. The decision of the authority in any case is final.

The tender must be accompanied with an " Earnest Money/Security deposit as mentioned above and it must be paid against demand draft to be drawn in favor of " BIDHAN CHANDRA KRISHI VISWAVIDYALYA", payable at UBI, BCKV, or SBI, KALYANI branch.
