Do not enclosed photocopies of the research publications etc. at this stage, but original reprints should be produced during the interview. Provide only the list of publications along with the application form. On the top of the envelope containing the application form, please mention "APPLICATION FOR THE POST OF (name of the post) IN KVKs UNDER BCKV" in block letters.

Fees: Payable in the form of Demand Draft only amounting to Rs. 1000/- for the post of Senior Scientist & Head, Rs. 500/- for the post of Subject Matter Specialist/T6 and Rs. 300/- for other posts, in favour of **Bidhan Chandra Krishi Viswavidyalaya** payable at Kalyani on any nationalized bank. Application fee is exempted for SC/ST and women candidates.

General Instructions:

- If a person desires to apply for more than one post, separate application form is to be submitted for each post.
- Only shortlisted/screened candidates will be called for written test and/or personal interview.
- Candidates working in Government/Public Sector Undertakings/Autonomous organizations (including departmental candidates) must apply through Proper Channel. They shall not be interviewed if they fail to produce no-objection certificate.
- Candidate below 18 years are not eligible for any of the posts.
- Relaxation of age for SC/ST/OBC candidate is allowed as per rules.
- No TA/DA will be borne by the Directorate for the candidates appearing for written test/interview.
- If at any stage, even after issue of the letter of appointment, a candidate is found ineligible for selection to any of the posts, his/her candidature will be cancelled without further reference.

Terms and Conditions of Service:

- I. The project and posts are purely temporary and the appointment shall be terminated on withdrawal of the post or scheme as the case may be by the ICAR. The appointing authority reserves the right to terminate employment by giving one-month advance notice. As the appointments are contractual in nature, renewals of appointment are dependent on the renewal of the project/post by ICAR.
- II. On termination of the posts or project as the case may be the incumbent shall not be entitled to placement/absorption etc. in any other KVK or project run in the University or in the permanent establishment of the University.
- III. Employees appointed against these posts shall not be entitled to employment / absorption / placement in BCKV or any KVK/Project run by BCKV.
- IV. Salary and other allowances are as per ICAR rules and shall be disbursed as and when fund is available under the KVK Project head.
- V. The employees shall not be entitled to any death-cum-retirement benefit other than provident fund, service conditions will be decided as per guidelines of the ICAR from time to time.
