
1. The rate must be ex-godown and without any container.

3. The entire cost of the above paddy as would be offered by the party and duly accepted by the authority will have to be paid to the concerned ADF against demand draft, within 7 days from the date of acceptance of the tender. Other wise his " Earnest Money / Security deposit will be forfeited.
4. The Non seed produces must be collected by the party at his own cost.
5. The tender along with requisit " Earnest Money "as specified below must be submitted for the above mentioned pady within the last date given below with out Earnest Money / tender will be treated as cancelled.




